

Job Description: Shift Supervisor

Reports to: Lead Shift Supervisor or Plant Manager

Position Overview

The Shift Supervisor will oversee direct reports in the execution of the production plan to meet the company's objectives and goals while maintaining safety as our top priority, followed by product quality and productivity.

Position Responsibilities/Essential Functions

- Safety is everyone's responsibility. Practice and follow plant safety programs and ensure compliance with good manufacturing practices (GMP's)
- Follow our quality management system and work instructions to reduce scrap through early detection and management of the auditing of finished goods. Direct resources to minimize scrap and control waste
- Understand and execute the production plan set by scheduling to meet delivery commitments
- Complete quality inspections to ensure manufactured product meets both customer and internal requirements
- Contain and document non-conforming product
- Maximize productivity and reduce unabsorbed labor through supervision and reporting of available resources including labor, materials, finished goods, and equipment
- Use IQMS to ensure correct production, scrap, and labor coding as well as accurate production paperwork
- Act as coach and facilitator in the delegation of daily tasks, create performance evaluations for review, and administer payroll for all direct reports on assigned shift
- Prepare disciplinary documentation for review and play an active role in resolving disciplinary issues
- Regular, on-time attendance at work is an essential function of every job at Dymotek
- Support the organization's needs in various functions
